Imported wines and spirits are subject to customs duties, consumption tax and excise tax, all of which are the responsibility of the CSBA to collect. Additionally, provincial regulatory bodies may require import permits and regulate allowable quantities when you import wine into Canada.

Reach out to your future wine supplier. The next step in the wine import process is to find and make contact with the potential wine suppliers you would like to start trading with. A good start can be to take a trip down to southern Europe and start knocking on the doors of the different vineyards you find interesting.
